Schedule Transition Conference if requested-document on an IFSP review.

Check Potentially Eligible for Special Education

Under Notification and Referral

Send your child's name, date of birth and your contact information (name, address, phone number) to the school division and Virginia Department of Education no earlier than the date provided below unless you disagree. Sending this information helps the school system to know who in the community may be eligible for special education services and is a referral to the local school division:
