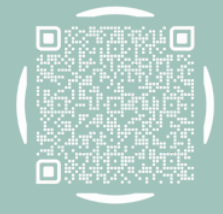

CSPD Oversight and Integration



- OSEP *Workforce Ready* grant has a new logo. Site visits to the four community colleges will take place March/April. Planning an IHE Institute for June.



- SSIP Pyramid Model Framework (PMF) Work Group meets monthly. The workgroup has developed three new products to begin orienting staff to the PMF. See [ITCVA PMF webpage](#).
- SSIP Reflective Supervision Workgroup has initiated a pilot study with the ITC-Chesapeake. In January, Service Coordinators at this location began monthly sessions of the Broadening the Lens curriculum followed by a group-based Reflective Supervision session. Service Coordinators and leadership personnel involved in this pilot have all been invited to participate in the research study examining the impact, utility and sustainability of the pilot model.
- SSIP Related Factors Work Group has submitted final recommendations to the Part C office. A subcommittee continues to work to develop guidance questions.
- SSIP Social Emotional Guidance Document Work Group was established out of the SSIP Screening and Assessment Work Group. This work group received permission to adapt [NYC's Social Emotional Guidance Document](#).
