

 - EI/Preservice Consortium
 - Expanding to include faculty from other disciplines, more than educators, SLP accepted, OT/PT/SW invited
 - o Goal grow more future El personnel
 - o Manuscript published in <u>DEC Leadership Monograph</u>
 - DEC presentation to help other states develop and implement this type of model to target EI shortage
 - Consortium webpage <u>link</u> (currently hidden):
 - Dimensions: Fundamental of El Short Course for New Providers:
 - 7 session short course completed with Dana facilitating.
 - Criteria for participation 18 months or less in El
 - Began August 31st with six sessions, every other Thursday for 90 minutes each, with a follow up session 6 weeks later in January.
 - We are in the process of looking deeply at the evaluation data we received from each session and from the short course as a whole.
 - O When participants were asked to share any impacts they noticed on their practice, many (if not all) were eager to report important ways the course positively changed their practice, like feeling more confident in having challenging conversations, or engaging families in coaching in a more meaningful way, including more observation and practice during coaching sessions. Participants also shared how they learned from each other during these sessions, such as trying out a particular open-ended question during the assessment or IFSP development process that resulted in better family involvement and understanding of the family's perspective and priorities.
