- 3. Updates on current ITC work and tie to ITCVA Priorities
 - Correlation to ITCVA Priorities
 - Strengthening LSM skills with fiscal management
 - LSM Meeting in March
 - Deana is coordinating with Beth and Kyla for planning. Meeting will have different focus because OSEP has shifted focus in monitoring. Part of meeting will have time for updates. Afternoon will be for strategic planning for measurement systems for fiscal management.
 - Beth shared that the state is now required by OSEP to develop state systemic improvement plan. Need to capture how well children are doing

 more focus on quality and outcome results for children and families.
 Meeting will be opportunity for LSMs to understand these new requirements and what is happening now.

 - Evidence-based practices behind EI discussed at LSM meeting in the fall. As a result of this discussion, there is now an EBP group (Kyla and Dana are facilitating).
 - New page on eipd site: Early Intervention: What It Is and Why It Works http://www.eipd.vcu.edu/ei what why.html
 - Basic training for service providers
 - Module revision work including introductory module
 - We are updating the content and format of the certification modules now. The revised modules will be packaged differently than in the past with smaller "chunks" to make the learning more accessible. Let us know if you are interested in helping with revision, sharing practical info/content, being videotaped, etc. We need you!
 - Cori is working with national group who is looking at developing a universal curriculum for info that is relevant regardless of your state. We will be able to take the info and adapt it to VA. Content being developed now revolves around 7 key principles.
 - Procedural Safeguards module is under final revision and will hopefully be ready for launch in March. This module should be about 20 min long. Thanks to ITC reviewers for their input!
 - O Content Acquisition Podcast (CAP) Jen is working with a UVA colleague on these 3-6 min videos with static content (does not change) that people can use to get quick info consistently in an easily digestible way. Cori and Jen will collaborate on 1-2 CAPs related to overview of Part C and what is EI (VA- Specific). This will be part of a package of basic training content.
 - Presenting at VA OT Association and SHAV
 - o Cori, Dana, and Corey Cassidy are presenting at SHAV.

- Carole Ivey has helped us get our foot in the door to VAOTA conference.
 Deana, Cori and Carole are presenting about sharing how to access info about EI (portal tools and resources that faculty and providers can use).
- We would like to link up with the VAPTA as well. Beth suggested that we get help from a local PT provider who is active in VAPTA. Kim Lephart has offered to assist with this.
- New webpage Faculty and Future Early Inteventionists

 - Not finalized yet but is live on site. Is a resource to answer students' questions and help faculty see how to use EIPD resources in their courses.
- Integrating the child indicators into the new IFSP
 - Working on developing video clips on assessment with child indicators
 - Anne is working through providing TA and information about practices at regional meetings. We are seeing more validity in our data, assessments are more functional, outcomes are more functional. Lots of great work that local systems are doing. Data is being reviewed to be sure that we have a good idea of how systems are doing across the state.
- Coaching initiative
 - Richmond Coaching in May 3,5, and 6 in Glen Allen
 - Registration just launched. Looking forward to getting this part of the state trained.
 - VCU TTAC collaboration is much appreciated!
 - Roanoke/SW Coaching in June 1st-3rd (tentative dates, no location yet)
 - o VA Tech TTAC collaboration is much appreciated!
 - By end of ITC year (end of June), we hope that every region of state will have had coaching training held.
 - Coaching initiative will continue to be a high priority for next year.
