  - Deana Deana received a call from another state with interest in our certification modules and wondered if her practitioners could take our modules. Exciting how our work is being used by others outside of Virginia.
  - Dana DEC has reached out to ask if their learning decks could be used by VA practitioners for certification credit. Dana is looking into it but thinks that their learning decks can be used towards professional development hours for recertification.
  - Beth APTA had a conference on DEC recommended practices. This is huge because it was reflection of them looking broader, beyond discipline.

## 2. State & National Activities

*I&TC office, T/TACs, VCPD, universities, local systems, Partnership, others Upcoming In-state events* 

- Cathy JMU T/TAC region 5 is hosting a follow-up event from their building blocks on Feb 27<sup>th</sup> which will be a literacy and math workshop; geared towards teachers of 3-4 year olds and kindergarten.
- Catherine ITCVA office is working on the State Systemic Improvement Plan (SSIP) which involves looking at child outcomes rather than just focusing on numbers served. VA has been cited as a leader in this effort and other states are being referred to us. Also working on annual performance report (APR) and funding application for next year. New regs were just released; everything is already in practice manual. Budget amendment is in General Assembly now for additional funds. There is also a budget amendment for increasing Medicaid case management rate to \$175.40; this amendment has not passed before. Will be watching these amendments.
- Beth We want wide stakeholder involvement with SSIP. See infantva.org website for more info under Monitoring and Supervision. Will need committee members in the future.
- Dana VCPD is hosting an institute for preservice and inservice faculty and PD providers in the coming year. Topic will be implementing the DEC recommended practices.

- 3. Updates on current ITC work and tie to ITCVA Priorities
  - Module Site Revisions
    - We have a new site that will eventually house all modules (certifications and ongoing PD modules) under development. We are now testing the new site to ensure that data will be transferred to the ITCVA office for certification. Testers are taking modules to make sure their scores on the quizzes transmit to the database at the ITCVA office. Once this is finalized, users will have one site which will hold all modules, scores, and certificates. We hope this will be more user-friendly.
    - $\circ$  If possible, please help us test modules if you receive an email requesting assistance.  $\odot$
    - New site is not live yet since it's still being tested. Old sites are still live.
    - Current certification modules will still be housed on the Principles and Practices site until they are revised. The new module site will be like a home page with links to all modules, including those still housed on the other site. Eventually, all certification modules will be directly linked from the new site, once revisions are completed.
  - Module Revisions
    - $\circ~$  Overview of Early Intervention nearing the review phase. Will include a module and videos.
    - $\circ~$  The Early Intervention Process module is proceeding with formatting. Will include multiple components too.
    - o Autism module no longer available online because it needs to be updated
  - Confidentiality video
    - Developed in partnership with Home Visiting Consortium. Features actors in situations where confidentiality may be in question. Is being filmed now.
  - Coaching Facilitation Guide
    - Work in progress
    - Tidewater is piloting the guide for feedback as it is developed. Very positive feedback received about having something concrete in hand to do with staff to support coaching.
    - Valley has also tried out activities and found them to be valuable for facilitating discussion among providers.
    - $\circ~$  ITC members liked idea for sending out an activity to the field until the whole guide is released.
    - Mira offered to try activities out with students too
  - <u>Brandon's Story, A Mother's Voice</u> video
    - Posted to the VEIPD website. An email blast will be coming out in the coming month or two to announce this resource.
    - Partnership director suggested we enter this video into some contests to get the word out on a national level.
