2. State and National Activities

- a. Part C Update
 - We are very happy to receive APRA funds from the Dept. of Ed and we have sent out a portion of these funds. We have until Fall of 2023 to fully disburse funds.
 - ii. We are working on a new data system to replace ITOTS which is called TRAC-IT. We held a demo last week and we are in the process of responding to questions from the demo. The new data system will go live in May. See the ITCVA Resource Library for ITOTS & TRAC-IT info.
 - iii. Providers are exhausted and we acknowledge that. We appreciate all of the work during this challenging time.
 - iv. We expect telehealth to become permanent through Medicaid so will be watching this.
- b. VA DEC No update. The VA subdivision is regrouping at the moment. Coordinating the subdivision is challenging without being able to see board members in person or at the conference.
- c. Conferences/PD Opportunities

d. DEC SC CoP

This group is developing infographics with vignettes to illustrate implementation of standards. The first one will be released in early Spring.
